SECTION 6. Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

7.1. Precautions for safe handling

Keep away from heat, sparks and naked flames; do not smoke or use matches or lighters. Without adequate ventilation, vapours may accumulate at ground level and, if ignited, catch fire even at a distance, with the danger of backfire. Avoid bunching of electrostatic charges. Vigorous stirring and flow through the tubes and equipment may cause the formation and accumulation of electrostatic charges.
